## **JOB RELATED REQUIREMENTS**

- A vulnerable sector check is a police information check plus a check to see if a person has a record suspension (pardon) for sexual offences
  - If you have been convicted of a crime in the past that is unrelated to working with vulnerable populations, you may still proceed with the application process. Please communicate this as your application progresses
- Tuberculosis (TB) Testing

Some programs and positions may require the following:

- Enhanced Security Screening requires Canadian Citizenship or Permanent Residence Status.
- Current Emergency First Aid Certificate\*
- Food Safe Level 1 Certificate\*
- Have and maintain a valid Class 5 driver's license
- Personal transportation that is in good repair, insured for business up to \$1,000,000 for liability, and which can be used to transport residents
